 - A **bid deposit equal to 10% of the total bid (including HST)** is required with all submissions. Deposits must be in the form of a **certified cheque** and will be returned to all non-successful bidders within **7 days** of tender award.

Item Removal & Transfer:

- No shipping is provided. Items must be **picked up within 30 calendar days** of award at the bidder's expense.
 - For vehicles, **ownership transfer, RMV registration, inspection, and insurance** must be completed by the buyer prior to release.
 - A **Bill of Sale** will be issued by the Town upon payment.
